- (b) the details of the quantum of indigenous production, demand, supply and imports of steel in the country during the said period;
- (c) whether there is a huge gap in the demand and supply of steel, if so, the details thereof and the reasons therefor;
- (d) whether the imports of steel particularly from China has adversely affected the domestic steel sector and if so, the details thereof;
- (e) whether the Government has received any representation from various domestic steel manufacturers against surge of steel imports in the country, if so, the details thereof along with the corrective steps taken by the Government to protect the domestic steel industry against the said imports; and
- (f) the other steps taken by the Government to boost the steel production in the country?

- (a) The domestic steel industry contributes to 2% (approx) in the nation's Gross Domestic Product (GDP).

Data on import of key items of non-alloy steel, overall alloy/stainless steel and total finished steel from China to India during the last three years and April-May, 2018 is given below. - (e) Government has not received any representation against surge steel imports in the country.
- (f) Steel is a deregulated sector. The Government has taken various measures to promote steel sector like trade measures such as anti dumping duties, safeguard duties and notified Quality Control Order thereby making BIS standards mandatory for all steel products and imports; notified the policy on Domestically Manufactured Iron and Steel Products in Government procurement which facilitates domestic value addition, and notified National Steel Policy, 2017 with a view to encourage long term growth of steel sector.
